What information is collected on Hermes.com?

You may use the Hermes.com website without providing any personal information to HERMÈS INTERNATIONAL. You will however, need to provide certain information, including your name, address, telephone number and e-mail address, as well as certain financial information (such as your charge or credit card number) if you choose to purchase products offered on the Hermes.com website for the purposes of paying for the products you ordered and processing your order. Any information you provide on the Hermes.com website may be processed in Ireland or in France and will be stored on HERMÈS INTERNATIONAL's server in France.
